The technical organizers for 2026 are the Norwegian Sailing Federation (NSF) and the Royal Norwegian Boat Federation (KNBF) together.

The conference is held every other year by the Nordic Boat Council. In 2026, Norway will be the host, and the conference will bring together leading professional environments, authorities, organizations, and experts from across the Nordic region – with a focus on shared challenges, new solutions, and the coordination of maritime safety efforts.

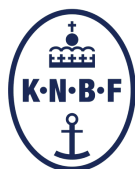
